Water Consumption Responsibility

At Harrington, we believe we have a responsibility to help transform the health of our planet. We also strive to operate in a sustainable and environmentally responsible manner as we deliver on our mission and strategic objectives through a commitment to embedding sustainability throughout our operational footprint. While Harrington is not a large consumer of water, we recognize the link between water use and climate change. We have several programs in place to manage water-related risks and govern our water usage beyond regulatory compliance.

Harrington's primary business dependency on water exists across our physical footprint of retail locations, distribution centers and field offices for the provision of fire sprinklers as well as water, sanitation, and hygiene services, in recognition of the United Nations(UN) General Assembly's Human Right to Water and Sanitation. As a warehousing distribution and logistics focused enterprise, our business impact on water outside these dependencies is negligible.

The UN Sustainable Development Goals (SDGs) serve as an important guide for this policy and Harrington's corporate social responsibility (CSR) roadmap. The SDGs that inform our Water Policy and align with our business impacts include:

- Goal 12: Responsible Consumption and Production.
- Goal 13: Climate Action.
- Goal 15: Life on Land.

Harrington proscribes to the UN Global Compact's tenants of the precautionary approach; environmental responsibility and the development and diffusion of environmentally friendly technologies further influence our water stewardship strategy.

Air Pollution, Emissions, and Greenhouse Gasses

As part of our approach to eliminating air pollution, we evaluate the potential impact of our emissions on the communities where we operate. We use these insights as we consider whether to advance appropriate capital projects and initiatives even as we work with regulatory agencies to assess and address potential air quality issues.

Our approach to air quality management includes:

- Understanding the composition and extent of our emissions.
- Meeting or exceeding environmental regulations.
- Reducing air emissions to minimize potential impacts on local communities.

Harrington supports public and private sector strategies and efforts to achieve significant reductions in air pollution and greenhouse gas (GHG) emissions through planning, design, partnership, and action.

Harrington is committed to:

- Establishing clear and reasonable targets and time frames for the reduction of GHG emissions.
- Establishing sustainable, long-term strategic business development roadmaps that target the reduction of GHG emissions.
- Improving energy efficiency and reducing GHG emissions produced by facilities and operations over their entire life cycles by making cost-effective use of existing and emerging technologies. The technology improvements should cover all sectors and include both brick and mortar and transportation systems and emission sources.
- Researching and implementing new technologies, operations processes, and materials to conserve resources to further improve energy efficiency and reduce GHG emissions.
- Encouraging and facilitating the use of lower GHG emitting energy-generating sources while accounting for the hazards, exposures, risks, and consequences of any energy source.

Supporting incentives for the short-term development and implementation of high-efficiency and low- or zero-GHG emitting technologies and cost-effective carbon capture and storage of emissions from large stationary sources that cannot easily be replaced or relocated.

Establishing market-based incentives and values for GHG emission reductions to stimulate investment in GHG reduction technologies among our supply bases.

Prioritizing renewable energy providers for electricity requirements for our brick-and-mortar facilities.

Investing in EnergyStar rated HVAC equipment and appliances within our facilities.

Investing in converting all lighting within our facilities to LED.

Investing in converting, wherever feasible, our powered industrial trucks and delivery vehicles to hybrid or electric models.

Establishing resources and guidelines to support our supply bases in establishing processes and methodologies specifically aimed at reducing air pollution.

Supporting Corporate Average Fuel Economy (CAFE) regulations that reduce GHG emissions from mobile sources.

This Statement aims to minimize our environmental impact, promote resource efficiency, and prioritize the safe handling and disposal of waste and hazardous substances, which includes -

- **Sustainable Materials Management:** We will continuously work towards a sustainable materials management system, prioritizing the use of environmentally responsible and recyclable materials wherever feasible. We strive to reduce the overall consumption of materials through efficiency measures and explore opportunities for circular economy practices.
